The second session will explore how constitutional review bodies as the ultimate guardian of fundamental rights can effectively respond to new challenges posed by the global changes in modern society and unprecedented crises like the ongoing COVID-19 pandemic.

The last session will focus on the universality of human rights and allow you to engage in an in-depth discussion on how the relationship between international human rights norms and constitutional rights is interpreted in

constitutional proceedings.

This International Symposium has a practical significance since most of us here are fulfilling our roles and performs responsibilities for institution that an constitutional adjudication in our respective countries.
